# Amendment of section 8, Act XVI of 2018

- In sub section (1) for the words "and six ex-officio (a) members out of whom at least three shall be renowned cultural activist women" the Word " other than ex-officio members out of whom at least one membershall be from each division and out of total non-official members at least 4 members shall be women" shall be substituted.
- (b) In sub-section (4),\_\_\_
  - (i) clause (d) and (e) shall be omitted;
  - (ii) for clause (c), the following shall be substituted;
  - "(c) Head of Fine Arts Department of Universities in Balochistan".
