The Balochistan Motor Vehicles (Amendment) Bill 2022, (Bill No.06 of 2022), having been passed by the Provincial Assembly of Balochistan on 26th February, 2022 and assented to by the Governor Balochistan, on 07th March, 2022 is hereby published as an Act of the Balochistan Provincial Assembly.

THE BALOCHISTAN MOTOR VEHICLES (AMENDMENT) ACT, 2022 ACT NO. V OF 2022.

AN ACT

further to amend the Balochistan motor vehicles ordinance,1965(ordinance XIX of 1965)

Preamble.

WHEREAS it is expedient to amend the Balochistan Motor Vehicles Ordinance, 1965 (Ordinance XIX of 1965) in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and Commencement.

- 1. (1) This Act may be called the Balochistan Motor Vehicles (Amendment) Act, 2022.
 - (2) It shall come into force at once.

Amendment of Section 2, Ordinance No.XIX of 1965.

2. In the Balochistan Motor Vehicles Ordinance, 1965 hereinafter referred to as the said Ordinance, in section 2, in clause (15), "including differently disabled persons with hearing impairment" shall be inserted.

Amendment of 3. In the Section 7, (5), in the Ordinance No.XIX added:-

- **3.** In the said Ordinance, in section 7, in sub section (5), in the proviso, after clause (b), the following shall be added:
 - applicant with hearing impairment (a) having up to 40 DB hearing loss shall wear hearing aids and in case the hearing loss exceeds 40 DB, the applicant shall use assistive technology devises or means as per vehicles description of special mentioned the A(K)in Form First Schedule."

- (b) The person who will take the driving test should know sign language or should be assisted by a person who knows sign language.
- (c) No license fee shall be charged from such person:
- (d) Provided that the vehicles of such persons shall attach mandatory stickers on their vehicles, as may be prescribed."

Amendment in Second Schedule of Ordinance No.XIX of 1965 **4.** In the said Ordinance, in the Second Schedule, serial No.5 shall be omitted.
