to amend the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975;

WHEREAS it is expedient to amend the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975 (Baluchistan Act No. II of 1975), for the purposes hereinafter appearing;

It is hereby enacted as follows -

per title and mmencement

- (I) This Act may be called the Baluchistan Assembly Members (Salaries and Allowances) (Amendment) Act, 1975.
- (2) It shall come into force at once and shall be deemed to have taken place from the 14th day of April, 1973.
- In section 2 of the Baluchistan Members (Salaries and Allowances) Act, 1975 (Caluchistan Act No II of 1975) hereinafter called the said Act,-
 - (a) after clause (f) the following new clause shall be inserted namely -
 - "(g) "Secretary" means the Secretary of the Assembly;" and
 - (b) existing clauses (g), (h), and (i) shall be re-lettered as claus (h), (i), and (j), respectively.
- In the said Act, after section 5, the following new section sh

be inserted, namely:-

"5-A. CONTROLLING OFFICER. The Secretary sh be Controlling Officer for the purpose of travelling allo ance admissible under this Act. ..
