This is not only wrong but cause of sorrow to all Baloch people. Hence, Federal Government ensure it that the said news agency to start publishing in Balochi as soon as possible.

iii. **Joint Resolution No.14** moved by Minister Abdul Raheem Ziaratwal, Sardar Raza Mohammad Barech, Advisor Agha Syed Liaqat Ali, MPAs Abdul Majeed Khan Achakzai, Spozmi Achakzai.

This house calls upon the provincial government to contact the Federal government that shortage of water in the province is worsening day by day. The volume of flood water in the province is 1400 to 1600 million acre feet annually, while the storage capacity of the flood water is only a few lac acre feet. On the other hand construction of hundreds of small dams is in pending due to non availability of funds from federal government. It is feared that instead of improvement the slow construction of dams may worsen the water shortage situation making people to migrate. It is government's prime responsibility to provide sufficient funds for the construction of dams in the province to ensure storage of flood water so that the impression of ignoring the Balochistan province could be removed.
