Subject:- **PRE-BUDGET DISCUSSION FOR THE YEAR 2022-23.**

Your kind attention is invited towards the provisions of Rules regarding general discussion seeking proposals of the Members for the next budget which is binding to be held during the months of February-April each year as per rule 115-A of the Provincial Assembly of Balochistan, Rules of Procedure and Conduct of Business, 1974 which is reproduced herein below for ready reference,—

**115-A.** (1) *Notwithstanding anything contained in these rules, the Minister for Law and Parliamentary Affairs, in consultation with the Finance Minister, shall include, in the list of business, the general discussion seeking proposals of the distinguished Members for the next budget in a session of the Assembly, which is to be held during the months of February to April each year.*

(2) *The general discussion on budget proposals shall take place for three days during the session or as the Speaker may determine.*

(3) *The Assembly may recommend the proposals to the Government for the next budget on conclusion of the discussion.*

2. Honorable Speaker while presiding over the Sitting of Assembly, held on 1<sup>st</sup> March 2022, has passed the following Ruling under rule 201-C of the Rules *ibid*:-

***"First three (3) working days of the Session proposed from 22<sup>nd</sup> March, 2022 shall be fixed/held for pre-budget discussion for the year 2022-23 under rule 115-A of the Rule of Procedure."***

3. In view of the above Ruling of Hon'ble Speaker and provision of Rules, your-honors are, therefore; requested to sensitize and direct all the concerned quarters to remain present during the entire discussion on the proposed dates so as to note down the proposals of the distinguished Members for further necessary action, please.
