The Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Bill, 1990 having been passed by the Provincial Assembly of Balochistan on 7th February, 1990 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly.

further to amend the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975 (V of 1975).

Preamble.

WHEREAS it is expedient further to amend the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act. 1975, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act. 1990.
- (2) It shall come into force at once and shall be deemed to have taken effect on 1st July, 1989.

Amendment of section 3 of Act V of 1975,

- 2. In the Balcohistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, for clause (d) of section 2, the following shall be substituted, namely:-
 - "(d) "maintenance" in relation to an official residence of the Speaker and the Deputy Speaker, as the case may be, includes the payment of local rates and taxes, water charges, electricity, gas and fuel charges."

Amendment of section 8-A of Act V of 1978.

- 3. In the said Act, for section 6-A, the following shall be substituted, namely :-
 - "6-A. Telephone.- The Speaker and the Deputy Speaker SHAIL DE ENTRIES to telephone facilities at office and residence at Government expense without celling both for official and private purposes throughout the term of their office and for a period of fifteen days immediately thereafter. They will also be entitled to free telephonic facility white on tour where such facility is available.

Insertion of 4. In the said Act, after section 13, the following new section 13-A in Act V of 1875. section shall be inserted, namely :-

ζ.

*13-A. Leave Allowances. The leave allowance of the Speaker and Deputy Speaker shall be rupers five thousand and rupees four thousand per mensum respectivly.

Amendment of 5. In the said Act, in section 15, for the words "two section 15 of Act V of 1975, thousand rupees and seven hundred and fifty rupees" the words "three thousand rupees and one thousand and five hundred rupees" shall be substituted.
