**Preamble.** 1. WHEREAS it is expedient further to amend the Baluchistan Local Government Ordinance, 1980, in the manner herein-after appearing;

It is hereby enacted as follows:-

**Short title & Commencement.**

1. (1) This Act may be called the Baluchistan Local Government (Amendment) Act, 1987.

(2) It shall come into force at once.

**Amendment of section 16 of Ordinance II of 1980.**

2. In the Baluchistan Local Government Ordinance, 1980, hereinafter referred to as the said Ordinance, after Section 16, the fullstop occurring at the end shall be substituted by a colon and thereafter the following proviso shall be added, namely:-

"Provided that he will not retain the Chairmanship if he becomes a Minister/Advisor in the Federal or Provincial Government".

**Amendment of section 22 of Ordinance II of 1980.**

3. In the said Ordinance, the existing section 22, shall be numbered as sub-section (1) of that section and in sub-section (1) as so numbered:-

(a) in clause (c), after the word "flag" a comma and the word, "symbol" shall be inserted.

(b) clause (f) shall be deleted.

(c) after the deletion as so made the following new sub-section shall be added:-

(d) "Notwithstanding any judgment, decree or order of the Court or Tribunal, a candidate shall not be disqualified from contesting election by reason only of his being a member of a political party".

**Repeal.**

4. The Baluchistan Local Government (Amendment) Ordinance, 1987 (1 of 1987), is hereby repealed.
