further to amend the Code of Criminal Procedure, 1898(Act V of 1898) in its application to Balochistan Province;

Preamble.

WHEREAS, it is expedient to amend the Code of Criminal Procedure, 1898(V of 1898) in its application to Balochistan Province in the manner hereinafter appearing;

It is hereby enacted as follows:-

**Short title and
commencement.**

(1) This Act may be called the Code of Criminal Procedure, 1898 (Balochistan Amendment) Act, 2021.

(2) It shall come into force at once.

**Amendment in Section 14-
A of Act V of 1898.**

3. In the Code of Criminal Procedure, 1898(Act V of 1898), in Section 14 A, after the words “price control”, the words and Commas, “forest, mines and in minerals, food adulteration, food safety, encroachments on public lands, waterways, canal and drainage, motor vehicles, building control and municipal Services, “shall be inserted.
