further to amend the Balochistan Assembly Members (Salaries and Allowances) Act, 1975 (II of 1975).

Preamble.

WHEREAS it is expedient further to amend the Balochistan Assembly Members (Salaries and Allowances) Act, 1975, in the manner hereinafter appearing;

Short title and commencement.

It is hereby enacted as follows :-

(1) This Act may be called the Balochistan Assembly 1.

Members (Salaries and Allowances) (Amendment) Act, 1992.

(2) It shall come into force at once and shall be deemed to have taken effect on the 17th day of November, 1990.

amendment of section 3 of act 11 of 1975. 2. In the Balochistan Assembly Members (Salaries and Allowances) Act, 1975, hereinafter referred to as the said Act, in Section 3, for the words "two thousand rupees" the words "four thousand rupees" shall be substituted.

mendment of ection 4 of ct II of 1975,

3. In the said Act, in section 4 for the words "two hundred rupees" the words "four hundred rupees" shall be substituted.

mendment of ection 5 of ct II of 1975.

4. In the said Act, in clause (c) of section 5, for the words "rupees one and twenty paisas" the words "rupees three and fifty paisas" shall be substituted.

nsertion of ew Section 5-B Act II of 375. 5. In the said Act, after section 5-A, the following new section shall be inserted, namely:

<u>"5-B. Free Travel Allowance.</u> (1) Every Member shall be provided during a year with vouchers of the value of thirty thousand rupees for the purpose of any journey within Pakistan without payment of any fare by Air or by Rail:,

Provided that where a person becomes a member during the course of a year, the value of the vouchers with which he is provided during that year shall not exceed the value which bears the same proportion to thirty thousand rupees as the un-expired portion of the year bears to a year.

(2) A member who does not wish to be provided with such vouchers shall be paid travelling allowance of twenty five thousand rupees in cash during a year for the purpose of any journey.

mendment of ection 6 of ct II of 1975.

6. In the said Act, in clause (b) of section 6, for the words "five hundred rupees" the words "three thousand rupees" shall be substituted.

Insertion of hew Section 6-A in Act 11 of 1975.

7. In the said Act, after section 6, the following new section shall be inserted, namely :~

"6-A, Office Maintenance allowance. A member shall be entitled to receive an office maintenance allowance at the rate of two thousand rupees per month.

Amendment of Section 7 of Act II of 1975.

- 8. In the said Act, in section 7:-
  - (a) In clause (a) for the words "rupees fifteen hundred per month" the words "rupees five thousand per month" shall be substituted.
  - (b) In clause (c) for the word "typist" the words "Senior Scale Stenographer" shall be substituted.

Insertion of new section 7-B in Act II of 1975.

- 9. In the said Act after section 7, the following new section shall be inserted, namely :-
- "7-B. Session allowance. A member shall be entitled to a session allowance of rupees five hundred per day for actual working days.
