Preamble WHIEREAS it is expedient further to amend the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act. 1975. (V of 1975 ) in the manner hereinafter appearing:

It is hereby enacted as follows:-

Short title and Commencement

1. (1) This Act may be called the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 2003.
