# THE BALOCHISTAN LAND LAWS (AMENDMENT) ACT, 2009 BALOCHISTAN ACT NO.1 OF 2009.

(First published after having received the assent of the Governor Balochistan in the Balochistan Gazette (Extra-ordinary) dated 7<sup>th</sup> April, 2009.

### AN ACT

### further to amend certain Land Laws

Preamble.

WHEREAS it is expedient further to amend certain land laws in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement

- (1) This Act may be called the Balochistan Land Laws (amendment) Act, 2009.
  - (2) It shall come into force at once.

Amendment of Certain Land Laws

 In the land laws specified in column 3 of following schedule to the Act are hereby amended to the extent specified against each in column 4 of the said Schedule.
