ACT

Further to amend the Balochistan Public Service Commission Act, 1989 (II of 1989).

#### **Preamble.**

WHEREAS, it is expedient further to amend the Balochistan Public Service Commission Act, 1989, in the manner hereinafter appearing:

It is hereby enacted as follows:-

**Short title and commencement.**

1. (1) This <sup>Bill</sup> Act may be called the Balochistan Public Service Commission (Amendment) Act, 2004.

(3) It shall come into force at once.

**Amendment of Section 3 of Act II of 1989**

2. In the Balochistan Public Service Commission Act, 1989 hereinafter referred to as the said Act, in section 3:-

(a) In sub section (3), for the word "Government" the words "Governor in consultation with the Chief Minister" shall be substituted.

(b) after sub section (3), the following proviso shall be added:-

"Provided that no person below the age of 55 years shall be appointed as Chairman or Member of the Commission".

**Amendment of Section 4 of Act II of 1989**

3. In the said Act, for section 4, the following shall be substituted:-

4. Terms of office of Chairman and Member.

(1) The term of office of the Chairman or a Member of the commission shall be five years:

Provided that a Member, who immediately before his appointment as Member was holding a post in the service of Pakistan may be transferred in public interest before the expiry of his term of office.

(2) The Chairman or a Member may resign his office by writing under his hand addressed to the Governor.

**Amendment of Section 6 of Act II of 1989**

4. In the said Act, in sub section (2) of section 6, after the words, figure and comma "Provisions of section 4." The words "recommended to the Governor to" shall be inserted.

**Omission of Section 7 of Act II of 1989**

5. In the said Act, section 7, shall be omitted.

**Repeal.**

6. The Balochistan Public Service Commission Ordinance, 2003 (III of 2003) is hereby repealed.
