No. PAB/Legis: V(16)/2004. The Balochistan Education Foundation (Amendment) Bill, 2004 having been passed by the Provincial Assembly of Balochistan on 7<sup>th</sup> May, 2004 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly.

### The Balochistan Education Foundation (Amendment) Act, 2004.

(Balochistan Act No. V of 2004)

(First published after having received the assent of the Governor of Balochistan in the Balochistan Gazette (Extra-Ordinary) dated 7<sup>th</sup> May 2004.)

#### AN ACT

to amend the Balochistan Education Foundation Act, 1994 (VII of 1994).

#### Preamble.

WHEREAS, it is expedient to amend the Balochistan Education Foundation Act, 1994, in the manner hereinafter appearing:

It is hereby enacted as follows:-

#### Short title and commencement.

- (1) This Act may be called the Balochistan Education Foundation (Amendment) Act 2004.

(2) It shall come into force at once

**Amendment of section 2 of Act VII of 1994.**

2. In the Balochistan Education Foundation Act, 1994, hereinafter referred to as the said Act, after clause (h) of section 2, the following new clause shall be inserted:-

“(ha) “Governor” means the Governor of Balochistan;

**Amendment of section 4 of Act VII of 1994.**

3. In the said Act: in sub sections (2) and (3) of section 4, for the word “Government” the word “Governor” shall be substituted.

**Amendment of section 5 of Act VII of 1994.**

4. In the said Act, in section 5, (a) for sub section (1), the following shall be substituted:-

“(a) There shall be a Board of Directors of the Foundation consisting of sixteen members of which not more than four will be official members as may be appointed by the Governor through a gazette notification. The Governor shall also be the Chairman of the Board”.

(b) In sub sections (1), (2), (3) and (4) for the word “Government” where-ever occurring, the word “Governor” shall be substituted.

**Amendment of section 6 of Act VII of 1994.**

5. In the said Act, in sub section (2) of section (6) for the word “Chairman”, the words “Managing Director”, Shall be substituted.

**Amendment of section 7 of Act VII of 1994.**

6. In the said Act, in sub sections (1), (2), (4) and (5) of section 7, for the word “Government” where-ever occurring, the word, “Governor” shall be substituted.

**Amendment of section 8 of Act VII of 1994.**

7. In the said Act, in section ‘8’ for the word “Government” the word “Governor” shall be substituted.

**Amendment of section 24 of Act VII of 1994.**

8. In the Said Act, in section 24, for word “Government” appearing twice the word “Governor” shall be substituted twice.

**Amendment of section 26 of Act VII of 1994.**

9. In the said Act, in section 26, for the word “Government” the word “Governor” shall be substituted.
