The Balochistan Assembly Members (Salaries and Allowances) (Amendment) Bill, 2003 having been passed by the Provincial Assembly of Balochistan on 25th February, 2003 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly:-

THE BALOCHISTAN MEMBERS (SALARIES AND ALLOWANCES)

(AMENDMENT) ACT, 2003.

ACT**

Further to amend the Balochistan Assembly Members (Salaries and Allowances) Act, 1975 (II of 1975).

Preamble

WHEREAS it is expedient further to amend the Balochistan Assembly Members (Salaries and Allowances) Act-II, 1975, in the manner hereinafter appearing:

It is hereby enacted as follows:-

Short title and commencement

1. (1) This Act may be called the Balochistan Assembly Members (Salaries and Allowances) (Amendment) Act, 2003.

(2) It shall come into force at once.

Amendment of Section 3 of Act II of 1975.

2. In the Balochistan Assembly Members (Salaries and Allowances) Act 1975, hereinafter referred to as the said Act, in section 3, for the words "four thousand rupees" the words "ten thousand rupees" shall be substituted.

Amendment of Section 4 of Act II of 1975.

3. In the said Act, in section 4, for the words "four hundred rupees" the words "five hundred and fifty rupees" shall be substituted.

Amendment of Section 5 (B) of Act II of 1975.

4. In the said Act, in sub section (2) of section 5-B for the words "twenty-five thousand rupees" the words "fifty thousand rupees" shall be substituted.

Amendment of Section 6 of Act II of 1975.

5. In the said Act, in section 6 for the words "three thousand rupees" the words "five thousand rupees" shall be substituted.

Amendment of Section 6-A of Act II of 1975.

6. In the said Act, in section 6-A for the words "two thousand rupees" the words "five thousand rupees" shall be substituted.

Insertion of Section 6-B in Act-II of 1975.

7. In the said Act, after section 6-A, the following new sections shall be inserted namely:-

"6-B. Sumptuary Allowance for Member. A Member shall be entitled to receive Sumptuary Allowance at the rate of "three thousand rupees" per month.

Amendment in Section 7(a) of Act II of 1975.

8. In the said Act, in clause (a) of section-7 for the word "rupees five thousand" the word "rupees twenty thousand" shall be substituted.

**Amendment in
Section 7(d) of
Act II of 1975.**

9. In the said Act, in clause (a) of section-7 for the word "five hundred rupees" the word "seven thousand rupees" shall be substituted.

**Insertion of New
Section 7-E in
Act-II of 1975.**

9. In the said Act, after section 7-D, the following new section shall be inserted, namely:-

7-E. Sumptuary Allowance for leader of Opposition. The Leader of Opposition shall be entitled to receive Sumptuary Allowance at the rate of rupees five thousand per month.

**Insertion of New
Section 10 in
Act-II of 1975.**

Official Transport for Chairman of Committee.

A Member who holds the office of a Chairman of a Committee of Assembly, other than that of a Select Committee or a Special Committee shall be entitled to the use of not more than one official car regardless of his entitlement to have an official car in any other capacity, and where he avails himself of this facility, he shall not be entitled to receive the conveyance allowance;

Provided that-

- (i) only one car shall be provided to a chairman of a (***) Committee during the whole term of his office;
- (ii) A Chairman of a (***) Committee shall be allowed "five thousand rupees" per month as P.O.L. charges.
