ACT

further to amend the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975 (III of 1975).

Preamble.

WHEREAS it is expedient further to amend the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances

and Privileges) Act, 1975. in the manner hereinafter appearing:

It is hereby enacted as follows :-

Short title
and
Commencement.

1. (1) This Act may be called the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 1992.

(2) It shall come into force at once and shall be deemed to have taken effect from the 17th day of November, 1990.

Amendment of
section 8 of

2. In the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, in sub section (6) of section 8, for the words "seven thousand rupees" the words "fifteen thousand rupees" shall be substituted.

Insertion
of new
section 8-A
in Act III
of 1975.

3. In the said Act, after section 8, the following new section shall be inserted, namely :-

"8-A. Hiring Ceiling. A fixed sum of rupees twenty thousand per month in lumpsum shall be paid to the Chief Minister and Provincial Ministers if they choose to reside in a hired house".

Repeal.

4. The Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Ordinance, 1991, (VIII of 1991), is hereby repealed.
