The Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Bill, 1990 having been passed by the Provincial Assembly of Balochistan on 7th February, 1990 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly.

ACT

further to amend the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975 (III of 1975).

Preamble.

WHEREAS it is expedient further to amend the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975 in the manner hereinafter appearing;

It is hereby enacted as follows :-

Short title and commencement.

1. (1) This Act may be called the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 1990.

(2) It shall come into force at once and shall be deemed to have taken effect on 1st July, 1989.

Amendment of section 6 of Act III of 1975.

2. In the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, in sub-section (2) of section 6, for the words "two thousand rupees" the words "three thousand rupees" shall be substituted.

Amendment of section 7 of Act III of 1975.

3. In the said Act, for section 7, the following shall be substituted, namely :-

"7. Transport:- The Chief Minister and a Minister shall be entitled to the use of official car maintained at Government expense throughout his term of office and for a period of 15 days immediately thereafter."

4. In the said Act, after section 7, the following shall be inserted namely :-

"7-A Telephone :- The Chief Minister and a Minister shall be entitled to telephone facilities at office and residence at Government expense without celling both for

official and private purposes throughout the term of their office and for a period of fifteen days, immediately thereafter. They will also be entitled to free telephonic facility while on tour where such facility is available."

Amendment of
section 8 of
Act III of 1975.

5. In the said Act, in section 8,
- (i) for sub-section (2), the following shall be substituted, namely :-
 - (2) The charges of electricity, fuel and gas in respect of Chief Minister and a Minister shall be borne by Government.
 - (ii) sub-section (3), shall be omitted.

Amendment of
section 15 of
Act III of 1975.

6. In the said Act, for sub-section (2) of the section 15, the following shall be substituted, namely :-

"(2) The leave allowance of the Chief Minister and a Minister shall be six thousand rupees and five thousand rupees respectively".

Amendment of
section 18-A of
Act III of 1975.

7. In the said Act, for section 18-A, the following shall be substituted, namely :-

"18-A Discretionary Grant:- A sum of rupees five lac and rupees fifty thousand per annum shall be placed at the disposal of the Chief Minister and a Minister respectively for making discretionary grants in such manner as may be prescribed".
