The Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Bill, 1989 having been passed by the Provincial Assembly of Balochistan on 3rd July, 1989 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly.

Preamble.

WHEREAS the Federal Shariat Court has directed further to amend the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975 in the manifer hereinafter appearing.

It is hereby enacted as follows:-

Short title and commencement.

- (1) This Act may be called the Balochistan Chief Minister and Provincial Midisters (Salaries, Allowances and Privileges) (Amendment) Act, 1989.
- (2) It shall come into force at once and shall be deemed to have taken effect on the 30th November. 1984.

Amendment of Section 10 of Act III of 1975

- In the Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) Act, 1975, after sub-section (3) of section 10, the following new sub-section shall be added, namely:-
- "(4) Where the Compensation is paid to the nominee, the nominee shall distribute the same amongst the heirs of the deceased according to their legal share."

Repeal. 3. The Balochistan Chief Minister and Provincial Ministers (Salaries, Allowances and Privileges) (Amendment) Ordinance, 1989 (VIII of 1989), is hereby repealed.
