BALUCHISTAN ACT NO. VIII OF 1985.

ACT**

to amend the Baluchistan Prevention of Gambling Ordinance,
1978 (X of 1978).

Preamble.

WHEREAS it is expedient to amend the Baluchistan Prevention of Gambling Ordinance, 1978 in the manner hereinafter appearing.

It is hereby enacted as follows :—

Short title and commencement.

1. (1) This Act may be called the Baluchistan Prevention of Gambling (Amendment) Act, 1985.

(2) It shall come into force at once.

Amendment of section 5 of Ordinance X of 1978.

2. In the Baluchistan Prevention of Gambling Ordinance, 1978 hereinafter referred to as the said Ordinance, in section 5, for the words "one year" and "five hundred rupees" the words "three years" and "five thousand rupees" shall be substituted, respectively.

Amendment of section 6 of Ordinance X of 1978.

3. In the said Ordinance, in section 6, for the words "two years" and "one thousand rupees" the words "five years" and "seven thousand rupees" shall be substituted, respectively.

Amendment of section 7 of Ordinance X of 1978.

4. In the said Ordinance, in section 7, for the words "three years" and "two thousand rupees" the words "seven years" and "ten thousand rupees" shall be substituted, respectively.

Omission of section 11 of Ordinance X of 1978.

5. In the said Ordinance, section 11, shall be omitted.

6. Any order passed, action taken or any decision made after the lapse of the Baluchistan Prevention of Gambling (Amendment) Ordinance, 1985 (XX of 1985) under the provision of the said Ordinance shall be deemed to have been validly passed, taken or made, as if this Act were in force on the day on which such order was passed or action taken or decision made.
