No. LEGIS-III (4)/85. The Baluchistan Assembly Members (Salaries & Allowances) (Amendment) Bill, 1985 having been passed by the Provincial of Baluchistan on 7th October, 1985 and assented to by the Governor of Baluchistan, is hereby published as an Act of the Provincial Assembly.

Preamble.

WHEREAS it is expedient further to amend the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Baluchistan Assembly Members (Salaries and Allowances) (Amendment) Act, 1985.
- (2) It shall come into force at once and shall be deemed to have taken effect on the 12th day of March, 1985.

Amendment of section 2 of Act II of 1975.

- 2. In the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975, hereinafter referred to as the said Act, after clause (f) of section 2, the following new clause shall be inserted, namely:—
 - "(ff) "Secretary" means the Secretary of the Baluchistan Assembly?

Amendment of section 3 of Act II of 1975.

3. In the said Act, in section 3, for the words "one thousand rupees" the words "two thousand rupees" shall be substituted.

Amendment of section 4 of Act II of 1975.

4. In the said Act, in section 4, for the words "seventy-five rupees" the words "two hundred rupees" shall be substituted.

Amendment of section 5 of Act II of 1975.

- 5. In the said Act, for section 5, the following shall be substituted:-
 - "5. Travelling allowance and mileage allowance.— A member shall be entitled to draw a travelling allowance for journey performed for the purpose of attending session, meeting of a Committee, or any other business as such member, from the piace where he ordinarily resides to the place where the session or the meeting is held or the other business is transacted or whenever a demand is made by the Provincial Government for the presence of the member of the Provincial Assembly at Quetta or any other place in connection with the visit of the President of Pakistan or the Prime Minister of Pakistan and for the return journey from the last mentioned place to the first mentioned place, at the following rates:—
 - (a) in case of journey by rail, an amount equal to one airconditioned class fare:
 - (b) in case of journey by air, an amount equal to one economy class fare;
 - (c) in case of journey by road, an allowance at the rate of rupee one and twenty paisas per kilometer when the journey in a vehicle not owned or maintained by Government is performed:

Provided that if the meeting of the Assembly is adjourned for a period of more than ten days, a member shall be entitled to travelling allowance for a journey performed from the place of session to the place where he ordinarily resides and back from such place to the place of session."

Amendment of section 6 of ... Act 11 of 1975,

- 6. In the said Act, in section 6,-
 - (a) the words "including a Deputy Speaker" shall be deleted.
 - (b) in clause (b) for the words "rupees two hundred" the words "five hundred rupees" shall be substituted.

Amendment of section 7 of Act II of 1975.

- 7. In the said Act, in section 7,-
 - (a) in clause (c) for the word "peon" the words "Naib-Qasid" shall be substituted.
 - (b) in clause (d) for the words "two hundred and fifty rupees" the words "five hundred rupees" shall be substituted.

Insertion of new section 7—A in Act II of 1975.

- 8. In the said Act, after section 7, the following new section shall be inserted, namely:—
 - "7-A. Medical facilities.— A member shall be entitled to medical facilities as admissible to a Government servant of a highest class under the West Pakistan Government Servants (Medical Attendance) Rules, 1959."
