No: Legis-X- 23)/74. The West Pakistan Motor Vehicles (Baluchistan Amendment) Bill, 1974, having been passed by the Provincial Assembly of Baluchistan on the 9th day of December, 1974 and assented to by the Governor of Baluchistan, is hereby published as an Act of the Provincial Assembly:-

**THE WEST PAKISTAN MOTOR VEHICLES (BALUCHISTAN AMENDMENT) ACT, 1974.**

**BALUCHISTAN ACT NO. XXI OF 1974.**

(First published after having received the assent of the Governor of Baluchistan in the Baluchistan Gazette (Extra-ordinary) dated 28th December, 1974.)

#### AN ACT

to further amend the West Pakistan Motor Vehicles Ordinance, 1965 in its application to the Province of Baluchistan.

Preamble.

WHEREAS it is expedient to further amend the West Pakistan Motor Vehicles Ordinance, 1965, in its application to the Province of Baluchistan, in the manner hereinafter appearing;

It is hereby enacted as follows :-

Short title,  
extent and

1. (1) This Act may be called the West Pakistan Motor Vehicles (Baluchistan Amendment) Act, 1974.
- (2) It extends to the whole of Baluchistan except the Tribal Areas.
- (3) It shall come into force at once.

2. (1) In the West Pakistan Motor Vehicles Ordinance, 1965 in its application to the Province of Baluchistan, herein after referred to as the principal Ordinance, in sub-section (i) of Section 49, after the words "Regional Transport Authority", the words, " a certificate of Group Insurance issued by an Insurance Company, duly approved and notified in the official Gazette by the Government of Baluchistan" shall be omitted and the words "certificate duly issued by the Baluchistan Transport Mutual Assistance Co-operative Society Limited, Quetta showing him (the applicant) as member thereof and the certificate so issued remains valid and is not withdrawn" shall be substituted.

(2) In sub-section (3) of section 49 of the principal Ordinance, after the words "is withdrawn by" the words, "the Insurance Company" shall be omitted and the words "Co-operative Society" shall be substituted.

3. In clause (a) of sub-section (1) of Section 67-F of the principal Ordinance, after the words "has furnished", the words "the certificate under Section 49, the company issuing such certificate" shall be omitted and the words "a certificate duly issued by the Baluchistan Transport Mutual Assistance Co-operative Society Limited, Quetta" shall be substituted.

Substitution of  
heading of thir-  
teenth Schedule.

4. The heading of the thirteenth Schedule namely "scale of compensation payable on injury to a passenger in a stage carriage or contract carriage by the Insurance Company as specified in Section 49 (1)" shall be substituted with the heading " scale of compensation payable on injury to a passenger in a stage carriage or contract carriage by the Baluchistan Transport Mutual Assistance Co-operative Society Limited, Quetta."

5. The West Pakistan Motor Vehicles (Baluchistan Amendment) Ordinance, 1974 (Baluchistan Ordinance No. V of 1974), is hereby repealed.
