**'THE ²BALUCHISTAN (AMENDMENT OF LAWS) (REPEAL)
ACT, 1974**

(Balochistan Act III of 1974)

An Act to repeal Balochistan Ordinance No. IV of 1974.

Preamble.

WHEREAS it is expedient to repeal the Balochistan (Amendment of Laws) Act, 1973, in the manner hereinafter appearing:

It is hereby enacted as follows: —

Short title and commencement.

1. (1) This Act may be called the Balochistan (Amendment of Laws) (Repeal) Act, 1974.

(2) It shall come into force at once.

Repeal of Act No. III of 1973.

2. The Balochistan (Amendment of Laws) Act, 1973 (Act No. III of 1973), hereinafter called "the Act", is hereby repealed; and the textual position of the laws, as listed in the Schedule of the Act, shall remain the same, as it was before the coming into operation of the Balochistan (Amendment of Laws) Ordinance, 1972 (Ordinance No. VI of 1972).

Effect of Repeal.

3. (1) Notwithstanding anything contained in any existing law including Acts, Ordinances, Orders, Rules, Notifications and Regulations, the provisions of this Act shall take effect and all appeals, reviews or revision petitions or any other case pending before the Board of Revenue, the Revenue Commissioner or a Deputy Commissioner or any other authority in pursuance of the Act shall stand transferred to the respective Commissioners and may be disposed of by them according to Law.

³[Provided that a case tried by a Deputy Commissioner, or any other court or authority, in its original jurisdiction under the laws listed in the Schedule of the Act shall not be affected, the trial thereof shall continue as before.]

(2) This repeal shall not, unless a contrary intention

appears: —

- (a) revive anything not in force or existing at the time at which the repeal takes effect; *or*
- (b) affect the previous operation of any enactment so repealed or anything duly done or suffered thereunder; *or*
- (c) affect any right, privilege, obligation or liability acquired, accrued or incurred under any enactment so repealed; *or*
- (d) affect any penalty, forfeiture or punishment incurred in respect of any offence committed against any enactment so repealed; *or*
- (e) affect any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid.

Removal of
difficulties.

4. The Government of Balochistan may by order make any provisions as may appear to be necessary or expedient for removing of difficulties in relation to the promulgation of this Act or any other matter supplemental thereto.

5. The Balochistan (Amendment of Laws) (Repeal) Ordinance, 1974¹ (Balochistan Ordinance No. IV of 1974) is hereby repealed.
