An Act to validate applications for the grant of resumed lands under Land Reforms (Balochistan Pat Feeder Canal) Regulation, 1972 (M.L.R. 117).

Preamble.

WHEREAS it is necessary and expedient to validate the applications for grant of resumed lands under the Land Reforms (Balochistan Pat Feeder Canal) Regulation, 1972 (M.L.R. 117) in the Province of Balochistan;

It is hereby enacted as follows: —

- Short title, extent and commencemen t.
- 1. (1) This Act may be called the Land Reforms (Balochistan Pat Feeder Canal) Regulation, 1972 (Validation of applications for the grant of resumed lands) Act, 1973.
- (2) It shall be deemed to have come into force with effect from the 12<sup>th</sup> day of May, 1972.
- (3) It shall extend to the Districts of Kachhi and Sibi in the Province of Balochistan.
- Validation of applications made under paragraph 7 (1) of the Regulation.
- 2. Notwithstanding anything contained to the contrary in sub-para (1) of para 7 of the Land Reforms (Balochistan Pat Feeder Canal) Regulation, 1972 (M.L.R. 117 of 1972) applications for the grant of resumed lands received before the Deputy Commissioner within whose District such land is situated, upto and on 15th June, 1972, shall be deemed to have validly been made.

Repeal.

3. The Land Reforms (Balochistan Pat Feeder Canal) Regulation, (Validation of applications for the grant of resumed lands) Ordinance, 1972 (Balochistan Ordinance No. VII of 1972) is hereby repealed.
