ACT**

to amend the Baluchistan Arts Council Act, 2018 (Act No.XVI of 2018)

Preamble: **WHEREAS**, it is expedient to amend the Balochistan Arts Council Act, 2018 (Act No. XVI of 2018) in the manner herein after appearing

It is hereby enacted as follows:

- Short title and commencement.**
1. (1) This Act may be called the Balochistan Arts Council (Amendment) Act, 2021
 - (2) It shall come into force at once.
- Amendment of section 8, Act XVI of 2018**
2. In the Baluchistan Arts Council Act, 2018 (Act No.XVI of 2018), in section 8,___
 - (a) In sub section (1) for the words “and six ex-officio members out of whom at least three shall be renowned cultural activist women” the Word “ other than ex-officio members out of whom at least one membershall be from each division and out of total non-official members at least 4 members shall be women” shall be substituted.
 - (b) In sub-section (4),___
 - (i) clause (d) and (e) shall be omitted;
 - (ii) for clause (c), the following shall be substituted;
“(c) Head of Fine Arts Department of Universities in Balochistan”.
