further to amend the Balochistan Service Tribunals Act, 1974 (Act No. V of 1974).

WHEREAS, it is expedient further to amend the Balochistan Service Tribunals Act, 1974 (Act No, V of 1974), in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short Title and commencement

1.

- (1) This Act may be called the Balochistan Service Tribunals (Amendment) Act, 2021.
- (2) It shall come into force at once.

Amendment of Section 4, Act V of 1974.

2. In the Balochistan Service Tribunals Act, 1974 (Act No. V of 1974) hereinafter referred to as the said Act, in section 4, in clause (a) for the word "Ninety" the word "thirty" shall be substituted.

Insertion of new section.

3. In the said Act, the existing S. No of section "5-A" with marginal heading "Controlling Authority" shall be renumbered as S. No "5-C) and thereafter following new sections with marginal headings shall be inserted:-

- "Review. 5-A (1) The Tribunal shall have the power to review its final order/ judgment on a review petition filed by an aggrieved party within thirty days of the order / judgment on the following grounds, namely:-
 - (a) Discovery of new and important matter or evidence which, after exercise of due diligence, was not within the knowledge of the petitioner or could not be produced

- by him at the time when the order /judgment was passed.
- (b) On account of some mistake or error apparent on the face of record; or
- (c) For any other sufficient cause.
- (2) The Tribunal shall decide the review petition within thirty days.
- (3) The Tribunal may confirm, set aside, vary, modify the judgment or order under review.

Execution. 5-B. A Tribunal shall have the **Power to Execute** its judgment /orders in accordance with procedure as may be prescribed in the rules made under this Act."
