Act**

to amend the Balochistan Holy Quran (Printing and Recording), Act 2015 (Act II of 2015).

WHEREAS, It is expedient to amend the Balochistan Holy Quran (Printing and Recording) Act 2015, (Act II of 2015) to constitute District Holy Quran Committees for collecting and disposal of damaged or Shaheed copies of Holy Quran..

It is hereby enacted as follows:-

**Short title, and
Commencement**

1. (1) This Act may be called as the Balochistan Holy Quran Printing and Recording (Amendment) Act, 2021.
(2) It shall come into force at once.

**Insertion Section
Section 8-A, in
Act II of 2015.**

2. In the Balochistan Holy Quran (Printing and Recording) Act 2015 (Act II of 2015) After section 8, the following section "8-A" shall be inserted:-

"Constitution of Committees:-

8-A The Religious Affairs Department by notification in the official Gazette, shall constitute a District Holy Quran Committee in every district, for the collecting and disposal of damaged/ shaheed copies of Holy Quran, comprising of the following:-

Deputy Commissioner
District Zakat Officer
Four (4) Ulema from each school of
thought Nominated by D.C (concerned)
Deputy Manager Auqaf of Concerned
District.
