### AN ACT

further to amend the Balochistan Motor Vehicles Ordinance, 1965 (Ordinance XIX of 1965).

Preamble WHEREAS, it is expedient to amend the Balochistan

Motor Vehicles Ordinance, 1965 (ordinance XIX of 1965)

in the manner hereinafter appearing.

It is hereby enacted as follows:-

Short title and commencement

- 1 (1) This Act may be called the Balochistan Motor Vehicles (Amendment) Act, 2022.
  - (2) It shall come into force at once

Amendment of Section 35 B Ordinance No. XIX of 1965.

In the Balochistan Motor Vehicles Ordinance, 1965, in section 35-B in sub-section (2) for the words "one year" the words "three years" shall be substituted.
