BILL

to amend the Balochistan Agriculture Markets Act, 1991

(1 of 1991)

Preamble.

WHEREAS it is expedient to amend the Balochistan Agriculture Produce Markets Act, 1991, in the manner hereinafter appearing;

It is hereby enacted as follows :-

Short title and commencement.

1. (1) This Bill may be called the Balochistan Agriculture Produce Markets (Amendment) Act, 2004.
- (2) It shall come into force at once.

Amendment of
Section 2 of
Act I of 1991.

2. In the Balochistan Agriculture Produce Markets Act, 1991, hereinafter referred to as the said Act, in Section 2 ; in clause (g), for the word "Deputy Commissioner" appearing twice the words "Director of Agriculture (Economics and Marketing)" shall be substituted twice.

3. In the said Act, in section 3, for the word "Deputy Commissioner" the words "Director of Agriculture (Economics and Marketing)" shall be substituted.

Amendment of
Section 8 of
Act I of 1991.

4. In the said Act, in section 8,

(i) in sub-section (3) for the words "Deputy Commissioner" the words "Executive District Officer (Revenue)" and in case there is no "Executive District Officer (Revenue)" the "Deputy Director of Agriculture (Economics and Marketing)" shall be substituted.

(ii) In sub-section (4) for the words "Deputy Commissioner" the words "Executive District Officer (Revenue)" and in case there is no "Executive District Officer (Revenue)" the "Deputy Director of Agriculture (Economics and Marketing)" shall be substituted.

5. In the said Act, in section 12, the full stop appearing at the end of proviso shall be deleted and thereafter the words and full stop and "Vice Chairman" shall be inserted.

6. In the said Act, in sub-section (1) of section 22, for the words "Deputy Commissioner" the words "Director of Agriculture (Economics and Marketing)" shall be substituted.

Amendment of
Section 24 of
Act I of 1991

7. In the said Act, in sub-section (2) of section 24, for the words "District Magistrate" the words "Session's Judge" shall be substituted.

STATEMENT OF OBJECTS AND REASONS

Since in the Balochistan Agriculture Produce Market Act, 1991 the word "Deputy Commissioner" exist and similarly the word "District Magistrate" exists. After the devolution of powers and creation of District Government it needs replacement to avoid legal complication in the said Act. The Agriculture Department proposed amendment in Section 2,3,8,12,22 and 24 of the

Balochistan Produce Market Act, 1991 by replacing the above said words by "Director Agriculture (Economics and Marketing)", "Executive District Officer Revenue" and "Session Judge". The Cabinet was also informed that the Balochistan Agriculture Produce Market Act, (Amendment) 2004, have been vetted by the Law Department.
