The Balochistan Employees' Social Security Institution (Amendment) Bill, 2024 (Bill No. 05 of 2024), having been passed by the Provincial Assembly of Balochistan on 24th December, 2024 and assented to by the Governor Balochistan, on 1st January, 2025 is hereby published as an Act of the Balochistan Provincial Assembly.

THE BALOCHISTAN EMPLOYEES' SOCIAL SECURITY INSTITUTION (AMENDMENT) ACT, 2024 ACT NO. VI OF 2025.

AN ACT

to amend the Balochistan Employees' Social Security Institution Act, 2022 (Act No.XXIX of 2022).

WHEREAS, it is expedient to amend the Balochistan Employees' Social Security Institution Act, 2022 (Act No.XXIX of 2022), in the manner hereinafter appearing;

It is hereby enacted as follows: -

Short title and Commencement.

- 1. (1) This Act may be called as "The Balochistan Employees' Social Security Institution (Amendment) Act, 2024".
- (2) It shall come into force at once.

Amendment in Section 75, Act XXIX of 2022.

- 2. In the Balochistan Employees' Social Security Institution Act (Act, No.XXIX of 2022), hereinafter referred to as the **"said Act"**, in section 75, in subsection (3)-
 - (a) for the word "fifteen" where-ever occurs, the word "fifty" shall be substituted;
 - (b) for the illustration the following shall be substituted,—

"Illustration. If the minimum wage rate determined by the Government is Rupees Twenty Thousand, then the upper wage limit shall be Rupees Ten Thousand (fifty percent of Minimum Wage) plus Rupees Twenty Thousand (Minimum Wage), equals to Rupees Thirty Thousands only."

Amendment in Section 79, Act XXIX of 2022.

3. In the said Act, in section 79, after the expression "Act XLV of 1860" the words "or civil servants as the case may be" shall be added.
