## AN

#### ACT

to amend the Balochistan Civilian Victims of Terrorism (Relief and Rehabilitation) Act, 2014 (Act No. IV of 2014).

#### Preamble.

WHEREAS, it is expedient to amend the Balochistan Civilian Victims of Terrorism (Relief and Rehabilitation) Act, 2014, in the manner hereinafter appearing.

It is hereby enacted as follows,-

# Short title and commencement.

**1.** This Act may be called as the Balochistan Civilian Victims of Terrorism (Relief and Rehabilitation) (Amendment) Act, 2025.

## Amendment of section-6 of Balochistan Act No. IV of 2014.

**2.** In Balochistan Civilian Victims of Terrorism (Relief and Rehabilitation) Act, 2014, (Act No. IV of 2014), hereinafter of referred to as the said Act,

In section-6(1), for the word "Government" the word "Chief Secretary Balochistan" shall be substituted.

In section-6(3), for the word "Government" the word "Chief Secretary Balochistan" shall be substituted.

and

In section 6(5), for the word "Government" the word "Chief Secretary Balochistan" shall be substituted.
