THE BALOCHISTAN MOTOR VEHICLES (AMENDMENT) ACT, 2025 (ACT NO. XIV OF 2025)

further to amend the Provincial Motor Vehicles Ordinance, 1965 (Ordinance xix of 1965)

Preamble.

WHEREAS, it is expedient to amend the Provincial Motor Vehicle Ordinance, 1965 (Ordinance No. xix of 1965) in the manner hereinafter appearing;

Short title and Commencement.

- This Act may be called the Balochistan Motor Vehicles (Amendment) Act, 2025.
 - (2) It shall come into force at once.

Amendment of Section 76. 2. In the Provincial Motor Vehicles Ordinance 1965 (Ordinance XIX of 1965) hereinafter referred to as the said Ordinance, in Section 76, in sub-section (2), after the words "tyres" the words "and is not exceeding the axle load as mentioned in Fifteenth Schedule" shall be inserted.

Amendment of Section 107.

In the said Ordinance, in Section 107, for the words "one hundred" the words "twenty-five hundrad" and for the words "five hundred" the words "five thousand" shall be respectively substituted.

Amendment in the Twelfth Schedule.

- In the said Ordinance, in twelfth schedule under headings "PENALTY RATES" "MOVING VIOLATIONS",—
