

Currently, the PAC is preparing its report on the Audit Report 2022-23, anticipated to be presented to the house in March 2025. Additionally, the Committee has issued notices for nine special audit reports referred by the House, aiming to examine each report thoroughly and submit its findings to the House by April 2025.

The Public Accounts Committee (PAC) has made significant strides in making sure the fiscal transparency and accountability. Notably, the Committee has examined approximately 85% of the Audit Report 2022-23, yielding substantial recoveries. As of the reporting period, the PAC has successfully recovered and deposited a total of Rs.412.907 million (Approximately) into the government treasury; demonstrating its commitment to prudent financial management and good governance.

#### **Automation of PAC Balochistan:**

A Model for Fiscal Transparency in Pakistan.

The delegation of Honorable members of Public Accounts Committees of Punjab visited the Provincial Assembly of Balochistan to observe Digital transformation of PAC.

A delegation from the Punjab Assembly, led by Chairman PAC-III Punjab Mr. Ahmad Iqbal, visited the Provincial Assembly of Balochistan to explore ways to enhance transparency, efficiency, and accountability in governance through technology. The delegation was warmly received by Chairman PAC Balochistan Mr. Asghar Ali Tareen and other illustrious members.

Mr. Ahmad Iqbal praised the PAC Balochistan for digitizing its operations through the Public Accounts Committee Information System (PACIS), which being a groundbreaking achievement undoubtedly offers valuable lessons for Punjab's PACs. Chairman PAC-II Punjab Mr. Ali Haider Gilani noted that Balochistan's automation of PAC is setting a remarkable example, especially by a resource-constrained province.

The delegation was briefed on PACIS's functions and its impact, while Chairman PAC Balochistan offered the system to the Punjab Assembly, ensuring complete cooperation in transfer of technology and knowledge sharing. This collaboration aims to strengthen fiscal oversight and accountability across Pakistan.

The PAC members inspected several projects, including:

- Historical and cultural heritage sites
- Gwadar Fishing Jetty and Gwadar Port

The committee praised the GDA's efforts for promoting local welfare and development. They also assured residents of these areas to find ways and means towards solutions to their problems. The visit highlighted the ongoing projects under the Gwadar Smart Port City Master Plan, which is aimed to promote employment, development, and improved living standards

### Sustainable Development Goals (SDGs) TASK FORCE

The Sustainable Development Goals (SDG) Task Force in Balochistan refers to a local body or collaborative initiative in the province of Balochistan, Pakistan, focused on implementing the United Nations' 17 SDGs at the provincial level. Balochistan, being the largest province in Pakistan with unique socio-economic and environmental challenges, requires dedicated efforts to address its development issues while aligning with global sustainability goals.

#### Key Functions of the SDG Task Force in Balochistan:

- 1. **Localized SDG Strategy**: Adapting the global SDG framework to the specific needs and priorities of Balochistan, considering local challenges such as poverty, lack of infrastructure, education deficits, gender inequality, and environmental concerns.
- Coordination with Stakeholders: The task force works with local government agencies, international organizations, civil society, private sector, and community groups to implement SDG-related projects and initiatives effectively.
- 3. **Monitoring & Reporting**: Tracking progress on various SDG targets within Balochistan, using data to monitor improvements or setbacks in key areas like health, education, water and sanitation, climate action, and economic growth.
- 4. **Policy Advocacy**: Collaborating with provincial lawmakers and government officials to integrate SDG principles into local policies, regulations, and development plans. The task force may also work on policy reforms that facilitate sustainable development.
- 5. **Resource Mobilization**: Identifying funding opportunities through national and international donors, and ensuring that resources are allocated efficiently to SDG projects.



- 6. **Capacity Building**: Training local stakeholders, including government officials, NGOs, and communities, on the SDGs and how they can contribute to achieving these goals.
- 7. **Public Awareness**: Educating and raising awareness among the people of Balochistan regarding the importance of SDGs and encouraging participation in sustainable practices across the province.

### Some Key Areas for Balochistan's SDG Focus:

Given the province's specific challenges, SDG Task Forces in Balochistan likely focus on issues such as:

- **SDG 1: No Poverty** Tackling high poverty rates in rural areas through economic development programs.
- **SDG 3: Good Health and Well-being** Addressing healthcare access issues, especially in remote areas, and improving maternal and child health services.
- **SDG 4: Quality Education** Expanding educational opportunities and improving school infrastructure, especially for girls.
- **SDG 6: Clean Water and Sanitation** Addressing water scarcity and improving sanitation facilities in the region.
- **SDG 13: Climate Action** Mitigating the effects of climate change, especially given Balochistan's vulnerability to droughts and desertification.

The **SDG Task Force in Balochistan** may also work in partnership with national SDG efforts, under the broader framework of Pakistan's commitment to the 2030 Agenda for Sustainable Development.


