The Balochistan Land Revenue (Amendment) Bill, 2025 (Bill No.31 of 2025) having been passed by the Balochistan Provincial Assembly on 08th September, 2025 and assented to by the Governor Balochistan on 15th September, 2025; is hereby published as an act of the Balochistan Provincial Assembly.

THE BALOCHISTAN LAND REVENUE (AMENDMENT) ACT, 2025. (ACT NO. XXVIII OF 2025)

AN ACT

to further amend the Balochistan Land Revenue Act, 1967 (Act. No. XVII of 1967)

Preamble.

WHEREAS, it is expedient to further amend the Balochistan Land Revenue Act, 1967 (Act No. XVII of 1967), in the manner hereinafter appearing;

It is here by enacted as follows:

Short title and Commencement.

- 1. (1) This Act may be called the Balochistan Land Revenue (Amendment) Act, 2025.
- (2) It shall come into force at once.

Insertion of Section 6-A, Act XVII of 1967. 2. In the Balochistan Land Revenue Act, 1967 (Act No. XVII of 1967), after section 6, the following new section shall be inserted, namely, -

"6-A. Renaming of District, Sub-division, etc. Notwithstanding the provisions contained in section 5 and 6, with the prior approval of the Government, a Division, District, Sub-Division, Tehsil and Sub-Tehsil or a part thereof, shall be-renamed, by the Board of Revenue, through notification to be published in official gazette:

Provided that for such naming and re-naming, the Government shall prescribe the criteria to be followed, in the Rules made under this Act."
