WHEREAS, it is expedient to further amend the Provincial Assembly of Balochistan Privileges Act, 1975 (Act No. VI of 1975), in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Provincial Assembly of Balochistan Privileges (Amendment) Act, 2025.
  - (2) It shall come into force at once.
- 2. In the Provincial Assembly of Balochistan Privileges Act, 1975 (Act No. VI of 1975), hereinafter referred to as the said Act in section 2, for clause (g), the following shall be substituted: -
  - "(g) "Member" means a Member of the Assembly and includes the Chief Minister, the Speaker, the Deputy Speaker, the Leader of the Opposition, a Minister, an elected Advisor to Chief Minister and a Parliamentary Secretary."

Insertion of new Section 18-A in Act VI of 1975. 3. In the said Act, after section 18, the following new section 18-A shall be inserted:-

#### "18-A. Provision of Security.

A Member shall be entitled to suitable and adequate official security at his discretion, for the duration of his term in office, as per following classification:-

- (a) the Government shall allocate as many security personnel as deemed necessary;
- (b) the Government shall allocate minimum of ten security personnel (Police or Levies) to the Speaker;

- the Government shall allocate minimum of eight security personnel (Police or Levies) to the Deputy Speaker;
- the Government shall allocate minimum of eight security personnel (Police or Levies) to the Leader of the Opposition;
- the Government shall allocate minimum of eight security personnel (Police or Levies) to a Minister;
- the Government shall allocate minimum of eight security personnel (Police or Levies) to an Advisor with the status of Minister;
- the Government shall allocate minimum of eight security (g) personnel (Police or Levies) to a Parliamentary Secretary; and
- the Government shall allocate minimum of six security (h) personnel (Police or levies) to a Member other than the above categories of Members.
