NOTIFICATION.

No.PAB/Legis:V(45)/2026/9603. The Balochistan Service Tribunals (Amendment) Bill, 2026 (Bill No. 45 of 2026), having been passed by the Provincial Assembly of Balochistan on 13th April, 2026, and assented to by the Governor Balochistan on 14th April 2026, is hereby published as an Act of the Provincial Assembly of Balochistan.

THE BALOCHISTAN SERVICE TRIBUNALS (AMENDMENT) ACT, 2026

(ACT NO. IV OF 2026).

AN

ACT

further to amend the Balochistan Service Tribunals Act, 1974 (Act No. V of 1974).

Preamble.

WHEREAS, it is expedient further to amend the Balochistan Service Tribunals Act, 1974 (Act No. V of 1974), to empower the appropriate authority to make rules for the purpose of regulating the appointment of persons to, and the terms and conditions of service of persons in the service of Balochistan Service Tribunal;

It is hereby enacted as follows: -

Short title and commencement.

1. (1) This Act may be called the Balochistan Service Tribunals (Amendment) Act, 2026.

(2) It shall come into force at once.

Amendment of section 2 of Act No. V of 1974.

2. In the Balochistan Service Tribunals Act, 1974 (Act No. V of 1974), hereinafter referred to as the said Act, in Section 2, in clause (b-i), the comma and the word “and” shall be substituted with semicolon and thereafter the following new clauses shall be inserted, namely: -

“(b-ii) →**prescribed**→ means prescribed by rules *and*;

(b-iii) →**rules**→ means rules made or deemed to have been made under Section 7 of this Act;”

Insertion of Section 6-B in Act No. V of 1974.

3. After Section 6-A, the following new Section “6-B” shall be inserted: -

“6-B. Terms and conditions of the employees. The terms and conditions of service of officers and employees of the Tribunal shall be as provided in prescribed manner.

Amendment of section 7, Act No. V of 1974.

4. In the said Act, in Section 7, -

(a) The existing provision shall be numbered as sub-section (1); *and*

(b) after sub-section (1), numbered as aforesaid, the following new sub-section shall be added, namely: -

“(2) In particular and without prejudice to the generality of the foregoing provision, such rules may provide for all or any of the matters relating to recruitment of officers

and employees of the Tribunal including the terms and conditions of their service, age of superannuation, beneficial and other funds, with or without Tribunal's contribution, for the officers and employees of the Tribunal; their welfare; providing amenities, medical facilities, their betterment and uplift; time-scale; up-gradation and the conduct, efficiency and discipline:

Provided that the provisions of the Balochistan Employees' Efficiency and Discipline Act, 2011 (Act No. VI of 2011) shall mutatis mutandis apply to the employees of the Tribunal, and the Government may also mutatis mutandis make applicable any rules made under Section 25 of the Balochistan Civil Servants Act, 1974 (Act IX of 1974), for the time being in force, to the officers and employees of the Tribunal, and such rules shall be deemed to have been made under this Section.”
