The Balochistan Public Service Commission

(Amendment) Bill, 2026 (Bill No. 01 of 2026), having been passed by the Provincial Assembly of Balochistan on 16<sup>th</sup> April 2026, and assented to by the Governor Balochistan on 27<sup>th</sup> April 2026, is hereby published as an Act of the Provincial Assembly of Balochistan.

**THE BALOCHISTAN PUBLIC SERVICE COMMISSION (AMENDMENT)**

**ACT, 2026 (ACT No. X of 2026).**

**ACT**

*further to amend the Balochistan Public Service Commission Act, 1989, (Act No. II of 1989).*

**Preamble.**

**WHEREAS**, it is expedient to further amend the Balochistan Public Service Commission Act 1989 (Act No. II of 1989) to empower the competent authority in the manner and for the purposes hereinafter appearing to amend and make provision for re-appointment of persons, as Chairman, who has previously held office as Chairman of the Balochistan Public Service Commission;

It is hereby enacted as follows:

**1. Short title and commencement.** (1) This Act shall be called the Balochistan Public Service Commission (Amendment) Act, 2026.

(2) It shall come in force at once.

**2. Amendment of section 4, Act II of 1989.** In the Balochistan Public Service Commission Act, 1989 (Act No. II of 1989), in Section 4, in sub-section (1), before the existing proviso, the following new proviso shall be inserted: -

“Provided further that a person who has previously held office as Chairman of the Commission may, notwithstanding the expiry of his term, be re-appointed as Chairman for one further term only, not exceeding three years:

**3. Repeal and saving.** (1) The Balochistan Public Service Commission (Amendment) Ordinance, 2026 (Ordinance No. I of 2026) is hereby repealed from the date of coming into force of this (Amendment) Act, 2026.

(2) Notwithstanding the repeal of the said repealed (Amendment) Ordinance (Ordinance No. I of 2026), anything done, action taken, orders or notifications issued and appointments made under the repealed (Amendment) Ordinance, shall be deemed to have been lawfully and validly done, taken, issued and made under the provisions of this Act.
