

**NOTIFICATION.**

**No.PAB/Legis:V(07)/2026/9909.** The Balochistan Levies Force (Amendment) Bill, 2026 (Bill No. 07 of 2026), having been passed by the Provincial Assembly of Balochistan on 14<sup>th</sup> May, 2026, and assented to by the Governor Balochistan on 19<sup>th</sup> May 2026, is hereby published as an Act of the Provincial Assembly of Balochistan.

**THE BALOCHISTAN LEVIES FORCE (AMENDMENT) ACT, 2026**  
**(ACT No. XIV of 2026)**

**AN  
ACT**

to amend the Balochistan Levies Force Act, 2025 (Act No. XXIV of 2025)

**Preamble.**

**WHEREAS**, it is expedient to amend the Balochistan Levies Force Act, 2025 (Act No. XXIV of 2025), in the manner and for the purposes hereinafter appearing.

It is hereby enacted as follows:

**Short title and  
Commencement.**

1. (1) This Act may be called as the Balochistan Levies Force Amendment) Act, 2026.
- (2) It shall come in force at once.

**Amendment of  
Section 2 of Act  
XXIV of 2025.**

2. In the Balochistan Levies Force (Amendment) Act, 2025 hereinafter referred to as the said Act, in section 2, clause (h), the following shall be substituted:-

"(h) '**Voluntary Separation Scheme**' means an amount prescribed in Schedule II of the Act for the members of the service of Ex- Federal Levies Force, who voluntarily/ willingly decide to leave the service before the age of Sixty (60) Years:

Provided that Voluntary Separation Scheme shall be allowed to the members who are above the age of fifty (50) years."

**Amendment of  
Section 40.**

3. In the said Act, in section 40, for sub-section (2), the following shall be substituted: -

"(2) Members of the Ex-Federal Levies Force who are above the age of fifty (50) years shall be offered an option to voluntarily separate from service, upon which they shall be entitled to a one-time ex gratia payment as prescribed in the Schedule II of the Act. Those who do not exercise this option shall continue in service until reaching the age of superannuation and shall, upon retirement, be entitled to pensionary benefits as determined/ calculated by the Finance Department."

**Amendment of heading of Schedule-II of Act XXIV of 2025.**

4. In the said Act, in Schedule-II, in the heading, the brackets and figure "(1)" shall be omitted.
